



## 7<sup>th</sup> ANNUAL MOUNTAINTOP HERITAGE DAYS Saturday & Sunday, June 30 and July 1, 2012

### FOOD VENDOR INFORMATION & APPLICATION

Planning is under way for the 7<sup>th</sup> **Annual Mountaintop Heritage Days**. The many activities conducted on both days and the Saturday evening fireworks have, over the past five years and depending on the weather conditions, attracted crowds of between 8,000 to 12,000 people to the parade grounds of the former Fort Ritchie Army base in Cascade, Maryland. This is the annual premier two-day event for the region.

Possible 2012 event activities on both days include live entertainment, children's activities and games, living history vignettes to celebrate the 150<sup>th</sup> Anniversary of the Civil War, a parade (Saturday), helicopter rides, boating on the lake, a car (Saturday) cruise-in, historical steam engines, and historical displays. And Saturday evening ends with a patriotic band program culminating in the first regional fireworks display for 2012. Sunday includes a Community Worship Program on the parade field.

This is an event that you will not want to miss! The food area is centralized in one location near the Fort Ritchie Community Center at the former Army base at Fort Ritchie in Cascade, Maryland. The plan is to continue to shrink the area of all the activities to allow for shorter walking distance between activities.

Expected food vendor operating hours are:

- Saturday - from 10:00 a.m. to 7:00 p.m. with the option of staying open later, but not after the start of the fireworks at 9:00 p.m.
- Sunday – from 10:00 a.m. to 4:00 p.m.

The event will be advertised. The 2011 event had daily promotions on multiple local radio stations, multiple listings in five local newspapers, and listings on internet calendars and tourist bureaus in the tri-state area as well as air time on NBC25, the region's local television station. The fee for the 2012 Mountaintop Heritage Days is \$100.00 per space if your application is *post marked* by 04/01/11. After this date, the fee is \$125.00 per space. (½ spaces are available for \$50.00 and \$62.50 respectively). Applications will be accepted until June 17<sup>th</sup>; thereafter, please call to see if spaces are available. Each space is 12x12. Electricity is limited (110 only) on a first come first serve basis; however, generators are welcome as long as they are not over 60 decibels. Set up will be Friday night from 4:00 p.m. to 9:00 p.m., and Saturday after 6:00 a.m. The festival will operate regardless of weather conditions. Application fees are non-refundable. Show fliers are available upon request.

All licensing and/or permits are the responsibility of the vendor. Food vendors are responsible for their own trash removal, tables and insurance. All waste produced by your food preparation/service shall be disposed of in your own sealed trash container as contained in the State of Maryland guidelines. Security will be on site both nights.
